## 7. Nethercott Road

Cllr. Rooke has shared via email (23.03.23) images of tarmac on Nethercott Road - he has photographs and dates [Cllr. Dart left 20:32]

This is the stretch of road from Nethercott Cross to Nethercott Farm/Tetcott.

Cllr. Greenaway elaborated: about six men arrived at around 11am in four vehicles to repair potholes yesterday (22.03.23) which were 'phoned in' about three days previously.

Two were marked up, one filled and one left. Apparently there was then tarmac dumped at the side of the verge; "there was more tarmac dumped on the side of the verge than on the filled pothole."

There have been several complaints raised by villagers and councillors, and so Cllrs. Rooke and Greenaway especially wish to register a complaint regarding the dumping of the tarmac, leaving a series of holes and "making use of what you've got."
